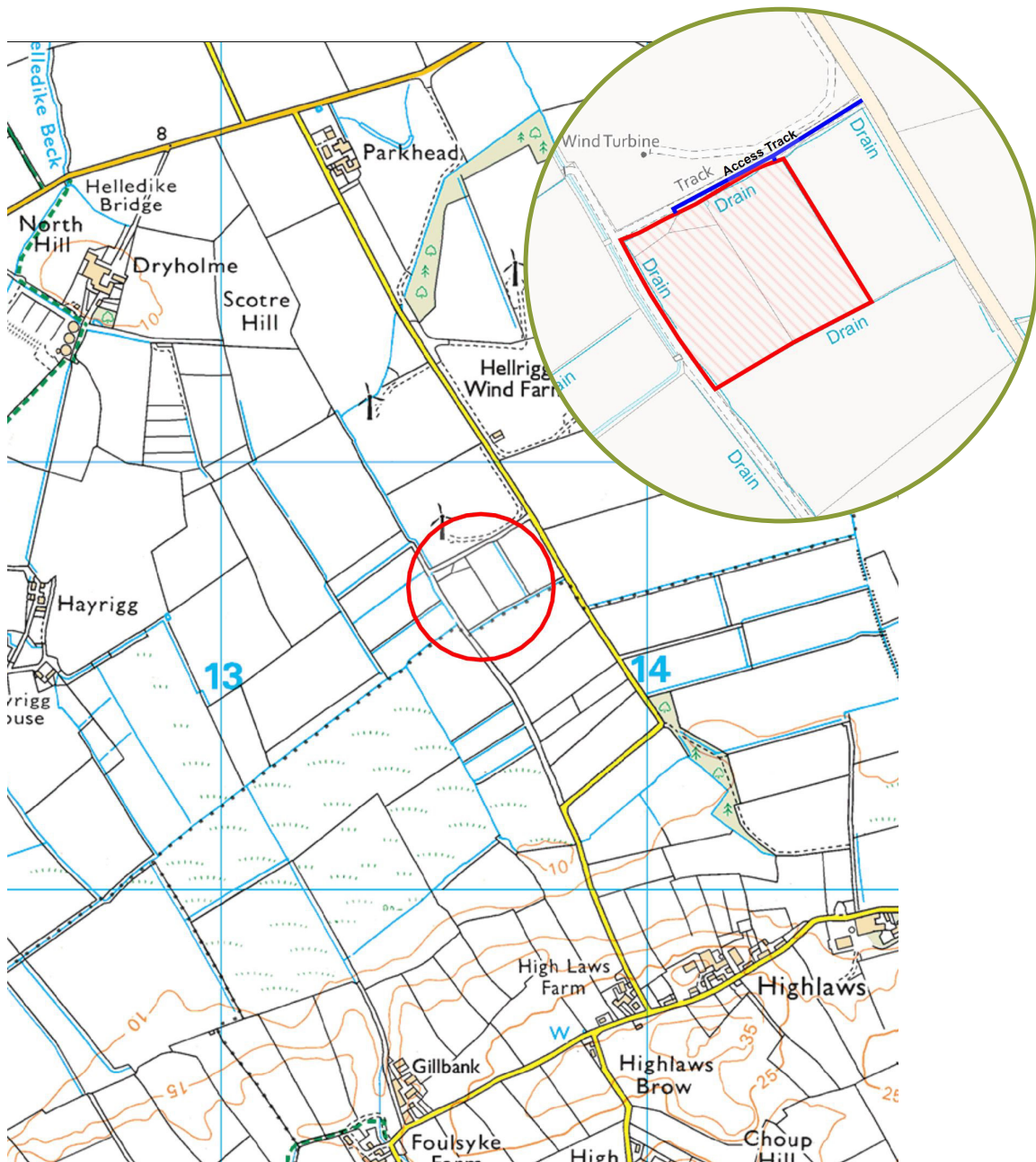

Abbeytown and southeast to the town of Silloth.

Access is via a shared access gravel track from the road leading from
Highlaws north to Park Head, as shown on the attached sale plan.

Two useful enclosures of grazing and mowing land extending to
approximately 6.93 acres (2.80 ha) within a single ring fenced block.
This secluded block of land may be of interest to those wishing to
purchase land suitable for equestrian use or for other grazing purposes
as well as mowing. The land is classified as Defra Grade 3.

The property will be offered for sale by Public Auction as a whole subject to reaching an undisclosed reserve price. Tenure

We understand that the title of the property is freehold.

Deposits and Contracts of Sale
