An excellent opportunity to purchase approximately 32.81 acres (13.28 hectares) of productive grassland suitable for growing arable crops located in a prime location near Micklethwaite, Wigan.

This block of land extending to 32.81 acres is located between the hamlets of Thornby and Micklethwaite. The town of Wigan is approximately 2.8 miles south west of the property. The land benefits from excellent roadside access to the A596.

Offered for sale are three excellent parcels of temporary grassland, all of which benefit from roadside access with two fields accessible from the A596 and the third accessed from the road leading to Thornby. This land is of exceptional quality being capable of growing a range of arable crops. The land is in good heart and good condition. The external boundaries on the land are in good condition benefiting from strong hedges and stock netting which are deemed to be stockproof.

The property has a metered mains water supply.

The property is well suited to those looking for productive arable and mowing/grazing ground.

Method of Sale

The property will be offered for sale by Public Auction as a whole subject to reaching an undisclosed reserve price. The Vendors reserve the right to alter, divide, amalgamate or withdraw any part of the lots and to generally amend the order of sale. Any changes will be made clear at the public auction.

Tenure

We understand that the title of the property is freehold and is offered for sale with vacant possession.

Exchange of Contracts, Vacant Possession and Completion

A 10% deposit of the purchase price will be payable on the fall of the auctioneers hammer and the contract of sale is to be signed. At this point, the purchaser must provide proof of identity and source of the deposit. Cash deposits cannot be accepted due to Money Laundering Regulations. Copies of the sale contract will be available for inspection by prior appointment only, at the offices of the Sole Agents during the week prior to the Public Auction. Completion is to take place six weeks after the date of auction with vacant possession given upon completion.

Environmental Schemes

The land is currently within a Sustainable Farming Incentive Agreement. It is anticipated this will not continue following sale.
